**DECLARATION OF STANLEY D. FERENCE III
IN SUPPORT OF MOTION FOR ENTRY OF
DEFAULT JUDGMENT AND PERMANENT INJUNCTION**

I, Stanley D. Ference III, hereby affirm as follows:

1. I am over eighteen (18) years of age and not a party to this action. I have never been convicted of a felony or any criminal offense involving moral turpitude, and I am fully competent to attest to the matters stated herein. I have personal knowledge of every statement made in this Certificate of Service and such statements are true and correct.

2. I am an attorney with the law firm of Ference & Associates LLC, which is located at 409 Broad Street, Pittsburgh, Pennsylvania 15143.

3. I am an attorney for the Plaintiff in the above-captioned case.

4. I make and submit this Declaration in support of Plaintiff's Motion for Default Judgment and Permanent Injunction (hereinafter "Motion for Default Judgment") against those Defendants for whom the Clerk has entered Default (the "Defendants").

5. On November 6, 2025 Plaintiff served all of the Defendants with Requests for Admissions, which included, *inter alia*, the following:

At all times relevant hereto, Plaintiff owned United States Copyright Registration Nos. VA 2-421-411, VA 2-420-610, and VA 2-420-594 (“Plaintiff’s Work”) and Defendant knew that Plaintiff had the exclusive right to use and license their intellectual property and the goodwill associated therewith.

Despite having the knowledge that you had no license or legal authority to do so, you engaged in the activity of promoting and otherwise advertising, selling, offering for sale, and/or distributing Infringing Products featuring, displaying, and/or using Plaintiff’s Work without authorization under your Seller ID(s) and/or Merchant Storefront(s).

At all times relevant hereto, you have been engaged in the fraudulent promotion, advertisement, distribution, offering for sale, and/or sale of goods that are infringements and/or unauthorized copies of genuine Plaintiff’s products.

You intentionally copied and/or infringed on Plaintiff’s Work.

You intentionally make, use, offer to sell, or import into the United States infringing and/or unauthorized copies of Plaintiff’s Products in connection with English language product listings, packaging, and instructions.

Not one of the Defendants in the Amended Schedule “A” has responded to the Requests for Admission, although some Defendants not included in the Amended Schedule “A” have responded. Thus, each Request for Admission is deemed admitted.

6. I am informed and believe that none of the Defendants are infants or incompetent persons, and upon information and belief, the Servicemembers Civil Relief Act does not apply.

I declare under the penalty of perjury laws of the United States of America that to the best of my knowledge the foregoing is true and correct.
